

Covid 19 response: Grant opportunities for Community Action

The voluntary sector, community and charities are playing a significant role and having an amazing impact on community resilience in response to Covid-19.

In recognition of the contribution being made and the potential financial pressures associated with that work, funding streams both existing and newly created have been adapting to meet the need. The situation is fluid with new grants and government support coming on stream as well as locally based fundraising appeals to meet immediate and pressing need. Gloucestershire Community Foundation (Gloucestershire) Name of Fund: Coronavirus Emergency Response Fund	The Gloucestershire Coronavirus Emergency Response Fund provides grants of up to £5,000 to charitable organisations and voluntary and community groups with charitable aims that are based and working in Gloucestershire. Teams in each shop will work together with their communities to choose the best way to use the fund. Tesco Name of Fund: Bags of Help	<p>Tesco is responding to the current Coronavirus (COVID-19) crisis by setting up a new short-term fund to support local communities:</p> <p>“Due to the need to respond quickly to the emergency we have created a streamlined application process and payment process to make it easier to get funds distributed quickly. If your application is successful the fund will provide a single payment award of £500 to organisations who are supporting vulnerable groups. Arts Council England Name of fund: Emergency Response Fund	Grants of up to £35,000 for creative organisations directly affected by the Covid-19 coronavirus emergency. Organisations must have been funded by public money over the last three years – for example, from the Arts Council, other Lottery funders, a university or local government. Applications are via the online portal only. Gloucestershire County Council Community Resilience Fund	<p>Gloucestershire County Council has delegated the management of £50,000 to each district, with specific criteria, to support community responses to the pressures created by Covid 19. CDC is looking to use this strategically, rather than replicate the funding support available as illustrated by the items above, or indeed preempt the support recently announced by the Treasury.
