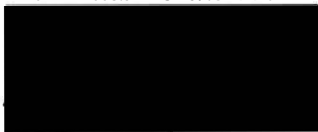

The Monitoring Officer of Cotswold District Council is required by law (under the Localism Act 2011 and associated regulations) to establish and maintain a register of interests of members and co-opted members of the District Council and every parish and town council within the Cotswold District.
