

GLOUCESTERSHIRE COUNTY COUNCIL
ON STREET PARKING ORDER 2017 (WEST END & MARKET PLACE) (TOWN OF NORTHLEACH)
(COTSWOLD DISTRICT) (VARIATION) ORDER 2023

NOTICE is hereby given that Gloucestershire County Council has made a Variation Order under Sections 1, 2, 3, 4, & 5 of Part I and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers, the effect of which will vary the Gloucestershire County Council On Street Parking Order 2017 (the 2017 Order) by introducing the restrictions on the roads detailed in The Schedule below in the Town of Northleach, Gloucestershire. The restrictions set out in the Schedule reflect an administrative exercise to ensure that the restrictions, as marked on street, match up with the legal order. There will be no physical changes to the existing restrictions as marked on street.

THE SCHEDULE

Restrictions to be introduced

No Waiting at Any Time (Double Yellow Lines)

Road Name & Number	Extent
West End (C332)	Along a short section on the north-eastern side of its carriageway north-west of its junction with Market Place (C332)

Restrictions to be revoked

No Waiting at Any Time (Double Yellow Lines)

Road Name & Number	Extent
West End (C332)	Along a short section on the south-western side of its carriageway north-west of its junction with Market Place (C332)
Market Place (C144)	Along a section of the western side of its carriageway south of its junction with Market Place (C332)

The lengths of roads fall within the Town of Northleach in the Cotswold District within Gloucestershire.

The 2017 Order will be varied by the attachment of plans similar to those used in this consultation and which identify the roads or sides of road to which the prohibitions and restrictions of waiting, loading and parking places affect. The usual exemptions will apply to Statutory Undertakers and Local Authority vehicles carrying out duties in exercise of their statutory powers, and also in the case of emergency services vehicles and disabled person's vehicles.

This Variation shall come into operation on 6th April 2023 and may be cited as the "GLOUCESTERSHIRE COUNTY COUNCIL ON STREET PARKING ORDER 2017 (WEST END & MARKET PLACE) (TOWN OF NORTHLEACH) (COTSWOLD DISTRICT) (VARIATION) ORDER 2023".

Any person wishing to question the validity of the Variation or any provision contained in it on the ground that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the ground that any requirement to that Act or any Statutory Instrument made under it has not been complied with in relation to the Variation may within six weeks of the date on which the Variation is made, apply to the High Court for this purpose.
